37 MINUTES

The minutes of the meeting held on 12 February 2008 were agreed and signed by the President as a correct record.

38 MATTERS ARISING ON THE MINUTES

- 27/15.16 The Hon Secretary advised that the Association had paid the ASA Membership fees of its 5 category 3 members.
- 27/22 Members pointed out that the management of the Windsor Leisure Centre had introduced evening charges for the Centre car park. The Hon Secretary was requested to approach the management of the Centre about the lifting of the charges in respect of the Association's meetings.
- 27/24 In view of her absence, it was again agreed that Mrs J Hopkins should be presented with a Past President's Badge at the next meeting.
- 30.5 It was pointed out that the Masters' Open Meet would be held on 4 October.
- 35A The Committee was advised that the price of tickets for the County dinner was £15, not £17.50, as recorded in the Minutes of the last meeting. The President expressed her hope that more younger athletes would attend the event.
- 35E The President reported that 23 people, from 10 clubs, had attended Fund Raising Workshop, a very good attendance.

39 REPORT OF REGIONAL DIRECTOR, ASA SOUTH EAST REGION

The Regional Director of the ASA South East Region circulated a report on significant developments or proposals for the future, covering:

- plans for a swimming development officer for Berkshire;
- volunteer development, including, for instance, that 16 persons from clubs in the sub-region had benefited from Regional bursaries;
- consultation of the Region's draft aquatic strategy;

- arrangements for the Regional Development Conference on the day of the Annual Council Meeting, 13 October 2008.

The Committee was reminded that there had not been a partnership swimming development officer (PSDO) for Berkshire since March 2006. The Regional Director, in her report, indicated that she had been exploring, with partners, how that deficiency might be addressed. One possible way forward was to seek funding, from the Big Lottery Fund, and specifically, its Family Learning programme. While a post funded in this way would need to satisfy the criteria for programme, it would also provide capacity to contribute towards of a PSDO.

Against that background, ASA South East Region was prepared to submit a bid to the Big Lottery Fund, but needed to be assured that the Association supported that approach. After a full discussion, it was, on the proposition of the Hon Secretary, agreed that the Association should strongly support the bid to be made by the Region, the Committee being confident that the Association's Berkshire-based clubs would welcome the opportunity to promote the benefits of swimming, in terms of healthy living and safe exercise.

5 Swimming

The Minutes of the meeting of the Swimming Committee held on 27 March 2008 were received. The suggestions or proposals set out in the minutes in respect of the Championships 2009 were adopted, viz:

- events to swum fastest to slowest
- 800/1500m events to be held at Aldershot
- redesignate the junior relay trophies for the Youth relay events
- entry fees to be £5 for individual events, and £6 for team events
- A and B finals to be held fro the [Senior] Championships, with awards for the top3 in the A final only
- 3 BAGCAT awards to be made in each age group.

The Generals Purposes Committee was authorised to approve revisions of the Swimming Championships Conditions, to reflect the above decisions, and to recommend revisions to the general Championships Conditions to the Annual Council Meeting. A proposal to add the 100IM event to the Championships was referred to the Annual Council Meeting.

The Committee endorsed the continued appointment of Ms E Waddy as County team manager and the appointment of Mr N Willis as assistant County coach.
